



### **FLY FREE OFFER - INDIA**

Atmantan has partnered with Tour Operators & Airlines to offer a special limited period offer for clients who will book their retreat with Atmantan.

***OFFER: With every room booking, 1 free Return Economy Class air ticket***

The terms and conditions are as follows:

1. The offer is valid for guests booking a minimum a 10 Nights wellness retreat.
2. The booking must be made such that the resort is able to make the flight booking atleast 30 days in advance.
3. Valid for all flights originating within India and outside of Maharashtra. A return ticket is the ticket that allows you to go back to the starting point of your travel.
4. Only ticket will be issued per room booking. For example: for a double occupancy room booking, ONE ticket will be issued without any additional cost.
5. 100% payment needs to be made in advance.
6. The booking is not refundable. The guest must avail their stay within 12 months from the date of booking.
7. Once the money has been received by Atmantan, the ticket will be issued within 36 hours. The luggage rules will apply as per Airline policy.
8. Once the airline ticket has been booked & issued by the resort, the resort will not be responsible for flight delays, rescheduling, cancellations, missed flight connections, delay/damage in baggage, theft, insurance etc.
9. The guests can avail of this limited period offer and keep their dates open for a period of 12 months. However, they will need to pay 100% advance and confirm their dates of travel atleast 30 days in advance to the resort. In case of open bookings, it is the responsibility of the guest to fill the airline booking form and send it to the resort.
10. Changes to Itinerary
  - a. AIRLINE TICKETS: If the guests want to reschedule their air tickets, then they must do this on their own & will be responsible for extra charges if levied by the airline/OTA/Travel agent.



b. STAY AT ATMANTAN RESORT: The resort doesn't charge any retention for amendments that are made more than 30 days prior to arrival. However, amendments requested within 30 days of arrival will incur a 1-night charge.

11. It will be our endeavour to fly the guests directly into Pune/ Mumbai (via Indigo/ Spicejet/Go Air/AirAsia or any other domestic carrier). However, if the Economy fares on these airlines are unavailable on the requested dates, then alternate Airlines (with single stop-overs) will be considered after consultation with the client.

12. Client will have to specify their flight preference in the following table for both the dates:

13. The guests will have to pay for the taxi transfer from the Mumbai/Pune airport.

14. This free ticket offer doesn't apply on & between the days of Dec 12<sup>th</sup> 2020 & Jan 3<sup>rd</sup> 2021.

15. If the total cost of the ticket (2 way tickets) is more than Rs. 12,000/- then the guests will bear the amount over and above Rs. 12,000/-.

16. Should a guest want to book their own ticket, a "Resort Credit" of INR 4,500.00 Will be extended which can be used against A La Carte Services.

17. Booking window for Offer: Valid from January 6<sup>th</sup> 2020 to Sept 30<sup>th</sup> 2020.

18. There is limited number. of tickets on flight routes and hence early booking is encouraged.

19. The offer can be withdrawn by written notice by the resort.
